4.3. NVSA still hesitant to allow the sharing of trails. NVATVC will continue to communicate and work with NVSA in pursuit of a harmonious, equitable, and respectful relationship.

4.4. Trillium Foundation Update: Theo needs costs for 2009 finalized to Theo help with securing funds through Trillium Foundation. Members asked to send ideas to Theo with estimated costs. Deadline for application is March 1st, 2009.

4.5. Kreg contacted Mr. Primrose about using a small 90cc Can-Am ATV Kreg for the Youth Rider Safety Program.

6.1. Rally Route to start at Winchester Service Centre, head north on St. Lawrence to the Gypsy Lane Road allowance and follow the trail around to the 400 Acres, to Ben's Pioneer, then all the way around to Rick's Gas Bar. Once at Rick's, participants will turn around and complete the circuit in the other direction.

6.2. The following work will need to be completed for the Rally:

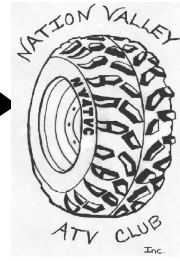
6.2.1. Trail to Rick's finalized and cut
